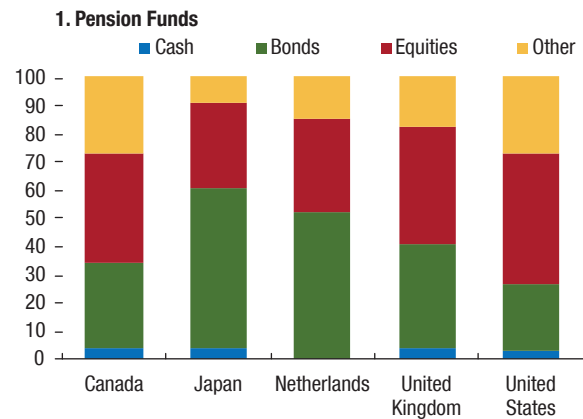
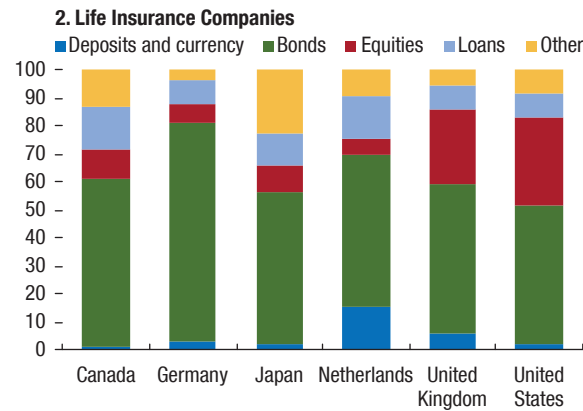


Figure 2.8. Asset Allocation of Pension Funds and Insurers, 2015
