


Financial Accounts of the United States




Other Financial Corporations

SDDS Plus: Other Financial Corporations Survey

- OFCS described in *Monetary and Financial Statistics Manual (MFSM)*
- Sectors included: Insurance corporations and pension funds, other financial intermediaries, and financial auxiliaries
- Instrument categories:
 - OFCs' claims on/liabilities to nonresidents
 - OFCs' domestic claims:
 - Net claims on central or general government
 - Claims of resident depository corporations
 - Claims on other resident sectors
 - OFC's liabilities to resident depository corporations
 - Other domestic liabilities
 - Shares and other equity
 - Other items (Net)



Data Dissemination

G-20 DGI Recommendation #20


Enhance the PGI website by closing gaps in availability of national data, improving the data timeliness and quality, and fostering international data cooperation by adopting the SDMX standards and implementing the common data structure definitions (DSDs) by statistical domain.

SDDS Plus Data Dissemination


- Requires an SDMX-ML format data file
- Can use either of two Data Structure Definition (DSD) types:
 - A dissemination DSD provided by the IMF
 - A DSD for global use
