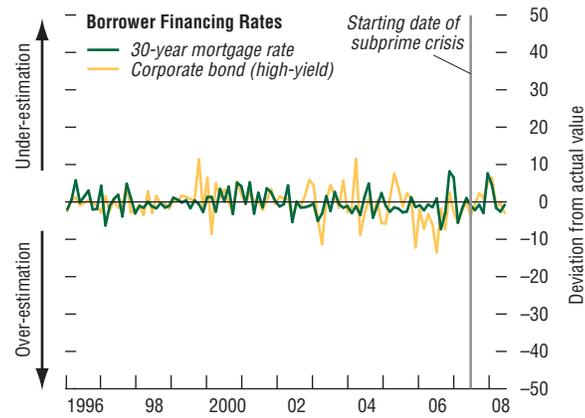
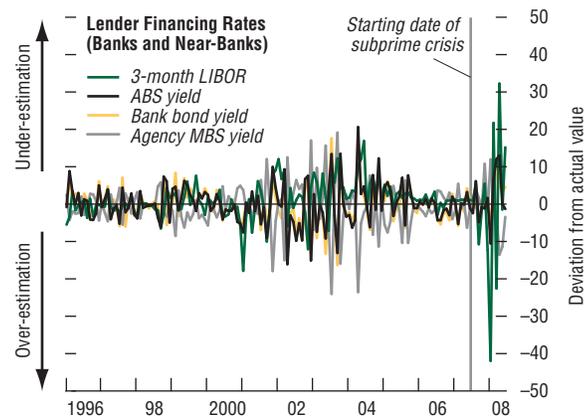


Figure 2.12. Summary Chart: Accuracy of Forecasts — U.S. Model, 1996–2008
