PREFACE

The analysis and projections contained in the *World Economic Outlook* are integral elements of the IMF's surveil-lance of economic developments and policies in its member countries, of developments in international financial markets, and of the global economic system. The survey of prospects and policies is the product of a comprehensive interdepartmental review of world economic developments, which draws primarily on information the IMF staff gathers through its consultations with member countries.
