where Q is the actual quota; Y is GDP in a recent year (1994); R is average monthly reserves in a recent year (1994); P and C are the annual average current payments and receipts, respectively, over a recent five year period (1990-94); VC is the variability of current receipts, defined as one standard deviation from a five-year moving average over a recent 13-year period (1982-1994); FMP is financial market accessibility times current payments; financial market accessibility is proxied by a variable which takes values of 4 for developing countries with limited access to private financial markets, 3 for the rest of developing countries, 2 for industrial countries with easy access to borrowing and 1 for France, Germany, Japan, the United Kingdom, and the United States; t-ratios are shown in parentheses.
