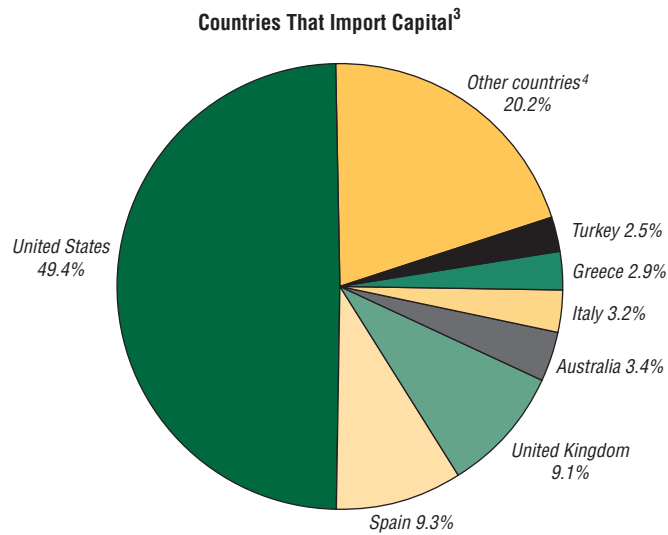
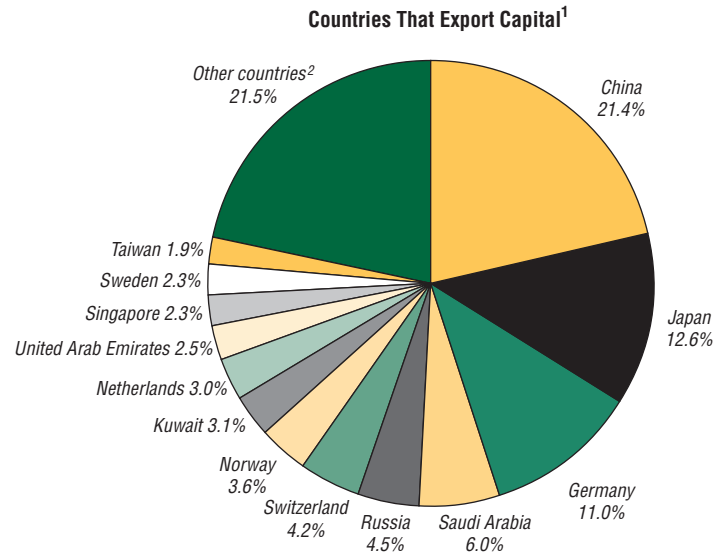


Figure 1. Major Net Exporters and Importers of Capital in 2007
