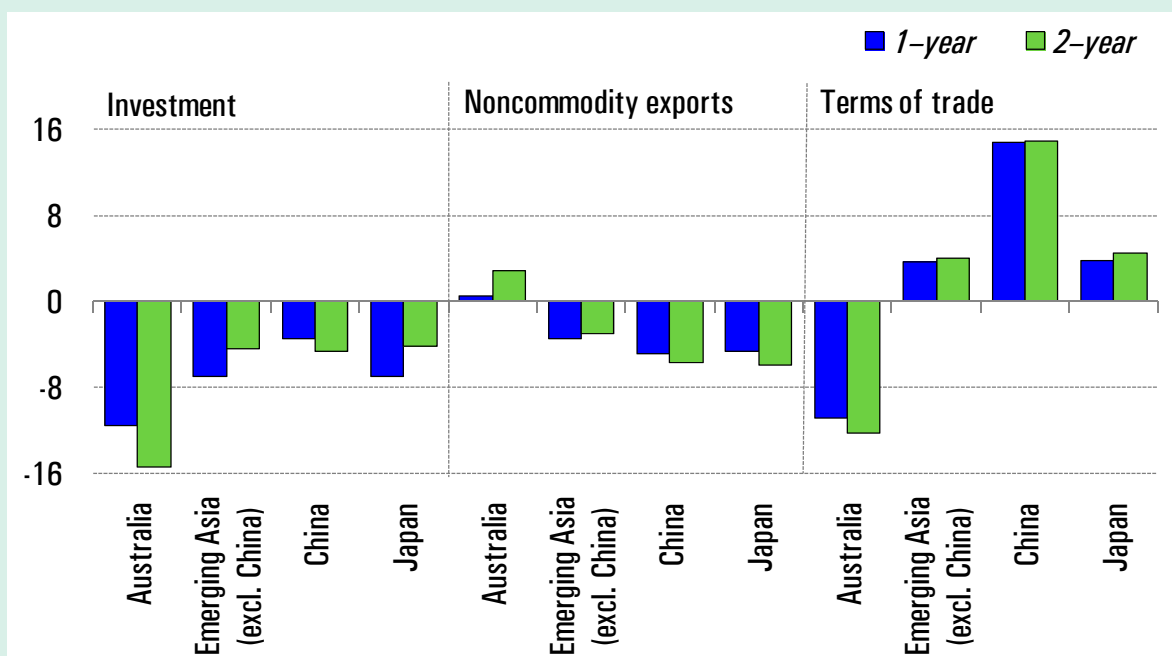


Figure 1.17. Selected Asia: Impact of Severe Global Slowdown on Selected Indicators¹
