
Figure 3.20. Change in Sensitivity of Inflation Expectations to Inflation Surprises

The sensitivity of inflation expectations corresponds to the response of inflation expectations to a 1 percentage point unexpected increase in inflation based on time-varying coefficients from country-specific estimations using a Kalman filter. The sensitivity for 5+ years corresponds to the average of estimations using 5- and 10-year-ahead inflation expectations. The change in sensitivity is constructed as the average deviation of the median sensitivity across countries from a linear trend (an exponential trend) fitted over the period 1997-2007 for countries at the ELB (not at the ELB). Countries at the ELB are defined as those with policy rates or short-term nominal interest rates of 50 basis points or lower at some point during 2008-15 and include: Canada, the Czech Republic, Estonia, France, Germany, Hong Kong SAR, Italy, Japan, Latvia, Lithuania, the Netherlands, Singapore, the Slovak Republic, Slovenia, Spain, Sweden, Switzerland, the United Kingdom, and the United States.
